2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and even social and economic losses which might result not only from their own actions, inactions or negligence but the actions, premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death. I fully understand that any medical treatment given will be first aid treatment type only.
4. Release, waive, discharge and covenant to sue Tazewell Tae Kwon Do.
