

**Adult & Minor Amateur Athletic Waiver
And Release of Liability**

In consideration of being allowed to participate in any way in the related events and activities, the undersigned:

1. Agree that parent(s) or legal guardian(s) will instruct the minor participants that prior to participating, and/or participant, he or she should inspect the facilities and equipment to be used and if the participant believes anything is unsafe, he or she will immediately advise his or her coach or supervisor of such condition(s) and refuse to participant.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and even social and economic losses which might result not only from their own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death. I fully understand that any medical treatment given will be first aid treatment type only.
4. 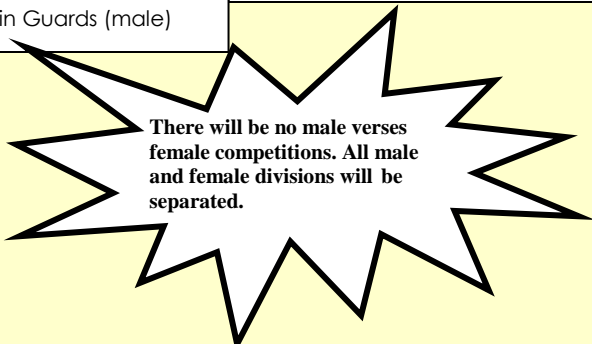
